Qualification obtained has to be from recognized University/Institute. Eligibility in terms of age, qualification and experience of a candidate shall be considered as on the last date for receipt of application.
- 3) Candidates meeting minimum eligibility criteria are not necessary to call for interview. Criteria's can be set to higher than minimum.
- 4) **No TA/DA will be paid for attending the Interview.**
- 5) In case of any inadvertent mistake in the process of selection, which may be detected at any stage even after issue of the appointment letter, the Institute reserves the right to modify, withdraw or cancel any communication made to the Applicants.
