Such applicants should submit a letter from their employer mentioning that they will allow the candidate to undertake this assignment, if selected.
3. Applicants who are employed in Government, Semi-Government, Autonomous Body or Institution should send their applications through proper channel. They will be required to produce the No Objection Certificate from their employer at the time of interview.
4. The candidates selected, shall be appointed on probation for two years.
5. The Institute reserves the right to fill or not to fill any or all positions.
